Emphasis will be placed on leadership's role in setting expectations, aligning policies, and modeling best practices that reduce institutional risk and promote a safe, compliant campus culture. Title IX Meets Wellness: Prioritizing Well-Being in a High- Impact Workplace	Red Flag/Green Flag Workshop: Understanding Healthy and Unhealthy Relationships	Athletics - NCAA Attestation, Compliance, Tier Prong Assessment
Title IX professionals carry immense responsibility—navigating complex cases, supporting trauma-impacted individuals, and ensuring compliance—all while managing their own well-being. This session explores the often-overlooked stressors of Title IX roles and offers practical strategies for integrating wellness into daily practice. Participants will learn why wellness is essential for trauma-informed work, discover tools to protect time and energy, and engage in interactive activities to reimagine office culture. Leave with actionable steps to sustain yourself and your team without sacrificing the quality of your work. Presenters: Krisshunn Youngblood, McNeese State University Location: The Suites (Foundation Suite P-Level 319 - Press Box Level)	This interactive session uses a creative “Red Flag/ Green Flag” game to help participants recognize warning signs and positive indicators within relationships. Through open dialogue and peer-led discussion, attendees will explore how everyday behaviors can signal respect, consent, and boundaries—or potential harm—and how campus communities can respond effectively. Presenter: It's On Us (UL Lafayette Student Organization) Location: The Suites (Media Room P-Level 326- Press Box Level)	This session will provide athletics and compliance professionals with strategies to meet NCAA attestation requirements and Title IX obligations within athletics programs. Participants will learn proactive approaches for monitoring misconduct risk, assessing program equity through the tier/prong framework, and integrating coach and student-athlete engagement to support accountability and compliance across teams.
